#### ADVICE FROM FIRST VICE COMMANDER

Greetings,

October is a busy month with several activities that I need to make you aware of, but, first, a follow up to last month's article about Post 305 financial status. budgets and cash on hand. At the September Executive Committee meeting the Finance Officer gave an outstanding report, in writing, with copies for everyone to look at. He answered many questions. patiently explained various line items in the budget, clarified that we actually have two checking accounts and one Certificate of Deposit. All accounts are at Woodforest Bank and total about \$36,000, instead of the \$38,000 that I bootlegged together for last month's report.

The budget format of expressing the <u>net</u> income to the Post on some line items, instead of showing all income, was discussed. The consensus was that this is "the way it's been done for years", so let's not change. This was further reinforced by a positive vote by the membership in accepting the budget as presented at the August meeting. For sure, this method does not reflect the actual income and expenses of the Post BUT, and it is a big BUT, I now believe it accurately reflects annualized bottom line income and expenses.

Now for the other activities mentioned. The annual cook-out is the third Thursday this month at Shadowbend Park. An abbreviated business meeting starts at 7:00 PM. Pray for rain, yes! If the burn ban is not lifted, we cannot have charcoal or any open-flame grills. Anyone for steak tartar and caviar?

The semi-annual Rummage Sale will take place on October 22, with set-up the day before, at the Robinson Road Community Center. If you have not left your donations at the storage locker, bring them to the sale site on setup day. Help is needed on both days.

There is a Joint Post/Auxiliary effort underway to "Fill a Tub" with move-in items needed when a homeless veteran transfers from a community group setting to an individual apartment. These tubs will be delivered to the District 7 Convention on Saturday, October 1, so please hustle your donations to any officer.

#### MEETING HIGHLIGHTS (September 15, 2011)

Commander Kim Biggerstaff opened the meeting in the customary manner and called on the Adjutant for a silent roll call. A quorum was present. Then the Commander called on Sergeantat-Arms Jim Bolin to identify any guests present, however; there **Finance Officer** were none. Dave Lips was absent so the Commander gave the current financial report, summarized as follows:

~General fund----- \$15,184.96 ~Allocated fund----\$21,708.64 ~Total assets----- \$36,893.60

Jim Bolin reported the Birdies for Charity figures were in and the Post will receive \$1.696.46 and the Auxiliary \$708.00. First Vice **Commander Emery Heuermann** reported that our paid membership stands at 241 or 60.5% towards our goal of 398. Commander Biggerstaff reminded all that the Fall Rummage Sale is on October 22nd and that articles for sale are needed, especially "big ticket items". The Commander also noted that the annual picnic is October 20<sup>th</sup> at Shadowbend Park.

Under "Unfinished Business", the Commander cited the fire around Bastrop and that the Unit had taken some supplies there earlier today. In fact the Executive Committee recommended a donation of \$100 be sent to the SAL Squadron at Bastrop and it was then approved by the membership. Another motion was approved to purchase newspaper advertising for the Rummage Sale.

**Mickey Fussell** gave a report about the ins and outs of going to a casino in Louisiana as a fun project. The Commander tentatively scheduled Tuesday December 6 as the day to go to the casino. Each individual who wants to go will have to make a reservation on the bus that goes to the casino and leaves from FM 1960 at 8 a.m. that day.

The Commander said that we were collecting items for a homeless vet to use upon moving into an apartment as a project for the District 7 Convention. The Commander also noted that we were participating in National Night Out on Saturday, October 1, at the Northshore Park from 1:00 to 5:00 PM. The Post voted to approve \$250 as a one-time expenditure to buy promotional material for our display.

**Pickens Jones** moved that we order fifty Entertainment Coupon Books as a fund-raising project. The motion passed. Books this year will cost \$49.95. Everyone is invited to purchase at least one book. They also make a nice gift.

There being no further business, the Commander closed the meeting "by the numbers".

#### WAR ON TERROR LOSSES (AFGHANISTAN)

Current NATO operations in Afghanistan are referred to as "Operating Enduring Freedom". Its price in American lives and those wounded, as of mid-August has been 1.728 deaths. which includes two DoD civilians. Of those killed, 1.368 were killed in action with the enemy; while 360 died of non-combat incidents. In addition, there have been 13,164 troops wounded in action during OEF. (Source: Air Force Magazine, September 2011)

#### A GOOD FRIEND OF RETURNING VETERANS

Some readers may be familiar with the mission of American Corporate Partners (ACP), but others will not heard of the nonprofit organization. This should remedy that.

ACP has three primary goals: (1) To assist returning veterans to the transition into corporate (2) То sector: grow and strengthen the network of veterans and corporate leaders in the private sector; and (3) To provide veterans with opportunities to leverage past military skills and experience in their career development.

ACP was conceived by Sidney E. Goodfriend, a retired investment banker, after the attacks of 9/11, and its aid is available to all interested and qualified service members who have served on active duty since 2001. It gives preference to those who have been deployed in support of the wars in Iraq and Afghanistan, as well as those with service-related disabilities. Spouses of those service members who were severely wounded or died while serving are also welcome to apply. Currently, ACP has signed on 31 major US corporations and a few universities from which volunteer "mentors" are drawn. Over 800 transitioning veterans ("protégés") are now beina assisted by a mentor on a one-onone basis.

ACP has offices in 17 cities, including Houston. There is also E-Mentoring program for an veterans residing more than 100 miles from a major city where the mentoring program is offered. This is not a formal jobs program. It is a tool for networking and long-term career development where each protégé (veteran) is matched with a senior corporate leader (mentor) who assists the GI to transitions back into civilian employment. One third of the veteran applicants have expressed an interest in small business development and entrepreneurship, so ACP created Small Business Resource а Center.

A profile of ACP's veteran applicants show 70% enlisted; 30% officers; 84% male; 16% female; average age=35; and 32% are 40 years old or older.

#### SURVIVOR'S ASSISTANCE

VA's Office of Survivors Assistance (OSA) ensures families of the fallen have full access to the services and benefits to which they're entitled. It was established by Public Law 110-389, Title II, Section 222, in October 2008, to serve as a resource regarding all benefits and services furnished by the Department to survivors and dependents of deceased veterans and members of the armed forces. OSA also serves as a principal advisor to the Secretary of Veterans Affairs and promotes the use of VA benefits, programs and services to survivors. The OSA is your advocate to ensure fairness, equity and appropriateness of all survivor benefits and to serve as the liaison for inter- and intra-agency collaboration and coordination on survivor OSA is also issues. fullv committed to staying in step with the needs of survivors to ensure that OSA remains а viable advocate for the survivor community. #### VETERANS OF ANY WAR ARE INVITED TO GO TO SCHOOL



Veterans Day recognition. There will be two presentations of the program on Thursday, November 10<sup>th</sup> – one at 9:00 AM and the other at 7:00 PM. The school is located at 27505 Glen Loch Drive, The Woodlands, 77381. The invite says to all veterans "—please come out and be honored at our program. The 4<sup>th</sup> graders are excited and are working hard for this special day. We would love it if anyone is interested could come and be part of this wonderful celebration."

#### THE LEGENDARY KILROY

There was one person who led or participated in every combat, training or occupation operation during WWII and the Korean War. This person could always be depended on to show up. GI's began to consider him the "super GI". He was one who always got there first, referring, of course, to "KILROY WAS HERE".

Somehow this simple graffiti captured the imagination of GI's everywhere they went. The scribbled cartoon face and words appeared everywhere world-wide. There are many legends about how Kilroy came to be, but the dominant one is that a shipyard inspector in Quincy, Massachusetts, James J. Kilroy, would chalk his name as "Kilroy was here" on completed ship bulkheads to show he had inspected the riveting of the new ship. To the troops going to war in those ships, the sign-off was a complete mystery. All they knew for sure was that Kilroy had been there first. As a joke, they began placing the same graffiti wherever they landed or went, claiming it was already there when they arrived. It became a challenge to place Kilroy in the most unlikely places. The over-the-fence character and the expression greeted US Navy UDT teams scouting Japanese island defenses before Marines landed. the Thev appeared in an outhouse at the Potsdam Conference. They were found atop Mt. Everest, in the Statue of Liberty, on the Berlin Wall and on the underside of the Arch de Triumphe. Wherever US troops, sailors and airmen served, they often found Kilrov had been there first. The tradition continued in every US theatre of operations and then faded in the 1950's as the Korean War ceased. But, those of you who served during those War Eras no doubt saw and perhaps helped Kilroy get around.
